CHAPTERED

- AB 114** **TITLE:** Education Finance
LAST AMEND: 06/28/2011
LOCATION: Chaptered
STAFF SUMMARY:
Repealed AB 3632 program and transferred responsibility to schools.
- AB 116** **TITLE:** Criminal Justice Realignment
LAST AMEND: 07/06/2011
LOCATION: Chaptered
STAFF SUMMARY:
Realignment of EPSDT and MediCal managed care together with community corrections alternatives to state prisons for "low level offenders," alcohol and drug programs, and child welfare.
- AB 922** **TITLE:** Office of Patient Advocate
LAST AMEND: 09/02/2011
LOCATION: Chaptered
STAFF SUMMARY:
Transfers the Dept. of Managed Health Care and the Office of the Patient Advocate to the Department of Health and Human Services.
POSITION: Support
- AB 989** **TITLE:** Mental Health: Children's Services
LAST AMEND: 05/27/2011
LOCATION: Chaptered
STAFF SUMMARY:
Existing law requires the 3 year MHSA plan to include information on programs including programs and services to children, including transition age youth 16 to 25 years of age. This bill would specifically include in the plan requirement transition age foster youth. Counties are concerned that this language would require that each county MUST HAVE services for foster youth which they would oppose instead of language that makes it clear a county only needs to CONSIDER services to foster youth.

- AB 1114** **TITLE:** Involuntary Administration of Psychotropic Medications
LAST AMEND: 08/15/2011
LOCATION: Chaptered
STAFF SUMMARY:
Prohibits the administration of psychotropic medications to inmates without consent; however, there are some exceptions. Most involuntary treatment will require a hearing and a court order.
- AB 1156** **TITLE:** Pupils: Bullying
LAST AMEND: 08/31/2011
LOCATION: Chaptered
STAFF SUMMARY:
Establishes and interagency council to address student crime, violence and bullying. Encourages schools to implement policies and procedures related to student crime, violence, etc.
POSITION: Support
- ACR 53** **TITLE:** Perinatal Depression Prevention
LOCATION: Chaptered
POSITION: Support
STAFF SUMMARY:
Establishes the Kelly Abraham Martinez Act. The Act urges all health/mental health services providers, and professionals that work with new mothers to invest in resources to educate families on perinatal depression. Also creates a collaborative to develop educational materials.
- ACR 77** **TITLE:** Suicide Prevention Week
LAST AMEND: 08/31/2011
LOCATION: Chaptered
STAFF SUMMARY:
Proclamation of suicide prevention week from September 4 through September 10.
- AJR 10** **TITLE:** School-Based Health Centers
LAST AMEND: 05/02/2011
LOCATION: Chaptered
STAFF SUMMARY:
Resolution to implement school based health centers as funded by the federal PPACA.
POSITION: Support
- SB 695** **TITLE:** Medi-Cal: County Juvenile Detention Facilities
LAST AMEND: 09/02/2011

LOCATION: Chaptered

STAFF SUMMARY:

This bill would provide Medi Cal benefits to juveniles awaiting adjudication.

TITLE: Health Care Coverage: Prescription Drugs

Relates the prior authorization process for prescriptions benefits.
